

****Gulf Breeze: Oil Spill Update****

May 9, 2010 72 Hour Forecast: No Oil Expected

Weather, winds and tides are holding the plume to the west and away from us for the time being.

Daily State Emergency Operations Conference call:

- Heavier winds hampered Gulf containment and burn activity
- An additional 5,000 feet of boom was deployed today in the panhandle
- Slick came ashore on some Louisiana islands
- Tarball reported on Dauphin Island, AL may not be related to this spill
- REPEAT: STATE INDICATES THAT ONLY PAID, TRAINED WORK CREWS SHOULD HAVE DIRECT CONTACT WITH OIL -- NO VOLUNTEER DIRECT CONTACT DUE TO HEALTH ISSUES
 - Critical tasks for which volunteers are needed are:
 - Coast watch and plume spotting
 - Wildlife support (food prep, transport, etc)

Other Items:

- City and ECS working to develop pilot tests of shoreline protection measures
- City staff to pick up skimmer from Tennessee

Volunteer Training available:

Module 1 (Basic HSE Training) – This volunteer would never come in contact with spilled oil (Ex: helping with beach cleanup at pre landfall conditions)

Module 2 (Contractors and Paraprofessionals) – This person would be a contractor conducting work at the staging site.

Module 3 (Wildlife Recovery and Rehabilitation) – This person would be a

trained Wildlife Recovery & Rehabilitation volunteer tasked with aiding in the clean-up of wildlife. It is a graded certification course.

Module 4 – Responders who might have direct contact with petroleum (this would include boat captains and crew who are already contracted to BP). Those who are not contracted must work through the Vessel of Opportunity program. Safety, Marine and Hazwoper training is delivered if their vessel is selected to be contracted through that program.

Friday, May 21- Modules 1&2 (45 minutes each, 6 p.m. at the Milton Community Center located at 5629 Byrom Street
